Step 2 – Open the PULSE Voucher Import Utility and click the "Read/Import File" button (see screenshot on prior page). Invalid vendor numbers, account numbers, etc., can easily be corrected on the screen. Unselect any entries that are not ready to be imported into your Macola® software.

Step 3 – Click the "Create Macola Vouchers" button (see screenshot on prior page). Only entries that have been selected will be imported. The imported entries can now be posted in the Macola $\$ software.
